You must be insured to take part in this holiday, please ensure that the cover you get is adequate. We advise that the insurance you take out not only covers you for sickness, injury & rescue whilst on holiday, but also any liability to ukalpine in case of your cancellation due to illness or any other circumstances. **NOTE:** We recommend that you do not pay for any flights or trip insurance until ukalpine has confirmed to you in writing that minimum numbers have been reached and that the holiday will go ahead.

Your booking must be accompanied by a deposit of 15% (minimum £150 per person) for which a receipt will be issued. In case of cancellation or significant change to the holiday by ukalpine an alternative will be offered, if this is not acceptable your deposit will be returned by cheque. Deposits will not normally be refunded for any other reason. No contract exists between us until written confirmation that the holiday will go ahead on the dates specified has been sent to you. Upon receipt of your deposit detailed trip notes and a confidential medical disclosure form will be issued. This should be completed, brought with you on holiday and kept in my trip file for the duration of the holiday, after which it will be either destroyed or returned to you.
